4. FIRST AID MEASURES

Inhalation:

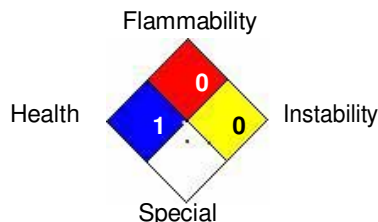
